**on or before April 30, 2023**

For the companies incorporated in Sri Lanka or outside Sri Lanka and for the Public Corporations, it is mandatory to submit ANNUAL STATEMENT OF ADVANCE PERSONAL INCOME TAX electronically. Other taxpayers are also encouraged to submit the same electronically.

- ✦ A taxpayer should have a Personal Identification Number (PIN) for e-filing. If a taxpayer does not have a PIN, he is advised to obtain a PIN
  - ✦ Through e- Services or  
[www.ird.gov.lk](http://www.ird.gov.lk) → e-Services → Access to e-Services → PIN Request
  - ✦ From Primary Registration Unit at IRD Head Office (1st Floor) or any Metro/Regional Office
- ✦ If individual taxpayers who have not received the statement could obtain a copy of the statement from the Customer Supporting and Promotion Unit at IRD Head Office or from any Metro/Regional Office
- ✦ Before filing the Annual Statement refer to the guideline issued
