STAMP DUTY (SPECIAL PROVISIONS) ACT, No. 12 OF 2006

SCHEDULE

By the deletion of items 12, 15 and 16 of the Schedule thereto and the substitution respectively therefore, of the following items ;

“12. (A) Any policy of life or medical insurance ; or

(B) Any policy of insurance on

(i) Plant, machinery or equipment used in the civil construction industry or agriculture ; or

(ii) Any motor vehicle other than any car or dual purpose motor vehicle of Class B of classification of driving licences for motor vehicles within the meaning of the Section 122 of the Motor Traffic Act, No. 14 of 1951 as amended by the Motor Traffic (Amendment) Act, No. 8 of 2009.



SCHEDULE (*Contd.*)

15. Any instrument relating to any finance lease executed in respect of any property other than any such finance lease in respect of any car or dual purpose motor vehicle of Class B of classification of driving licences for motor vehicles within the meaning of the Section 122 of the Motor Traffic Act, No. 14 of 1951 as amended by the Motor Traffic (Amendment) Act, No. 8 of 2009.
16. Any hire purchase agreement entered into under the Consumer Credit Act, No. 29 of 1982 in respect of any moveable property other than any car or dual purpose motor vehicle of Class B of classification of driving licences for motor vehicles within the meaning of the Section 122 of the Motor Traffic Act, No. 14 of 1951 as amended by the Motor Traffic (Amendment) Act, No. 8 of 2009.”
